**Hours of Operation:** PIC is open from 8 am - 6 pm. There is no early care option until further notice.

**Calendar:** Please see the PIC website for the days that PIC is closed for holidays and/or staff professional development days. Families are responsible for the full monthly tuition regardless of the days that PIC is closed.

**Facilities Fee:** Each family in the **Early Learning Program** and in the **After School Center** will be assessed an annual fee of **\$100** in the September billing. This fee will go directly to funding PIC's facilities needs and improvements.

**Food Program:** Our Food Program is included in the monthly tuition payment. This includes two snacks and a warm lunch each day in the Early Learning Program and an afternoon snack in the After School Program.

**Tuition Comparison:** When comparing PIC tuition with a center that quotes weekly rates, divide the monthly rate by 4.3.

**Payments:** Monthly tuition is due by the 5<sup>th</sup> of each month. Families are charged the monthly rate regardless of PIC scheduled closings.

Payments can be made via cash (given to the Accounts Manager), check (payable to Parent Infant Center), ACH, or credit card. All fees associated with ACH or credit card payments are the responsibility of the payee. **Fees assessed are 0.5% (minimum \$0.25, maximum \$1) per ACH transaction and 2.75% per credit card transaction. These charges serve as a reimbursement of actual charges incurred by PIC.**

**Tuition Changes During the Year:** For children enrolled in the Early Learning Program, tuition goes down when your child moves to the next age group. If the move occurs before the 15<sup>th</sup>, tuition is reduced on the first of the month. If the move occurs after the 15<sup>th</sup>, it is reduced on the first day of the following month.

**Part-day Preschool Program:** This program follows the calendar of the School District of Philadelphia. These classrooms are closed on the full-day closures listed on the School District Calendar and are dismissed at noon on the ½ day closures listed on the School District calendar.

**After School Center:** Tuition is based on **9 equal payments** from **September** through **May**. Tuition for the months of **August and June** will be **prorated**, dependent upon the start and end dates set by the School District of Philadelphia and posted on their annual calendar. The fee includes up to 12 half-days

and up to **10** full-day school holidays for children enrolled full-time in ASC. Children enrolled for up to 4 days receive up to **7** full-day school holidays; children enrolled for up to **3** days receive up to **5** full-day school holidays. If the School District of Philadelphia changes their calendar, families will be charged for additional half and full day closures.

**Subsidy:** Child Care Works (CCW) subsidy is accepted for all age groups. CCW subsidy is determined on a sliding scale by family size and income (family income up to 300% of the federal poverty line.) Families are responsible for paying PIC the weekly co-pay that is set by the CCW program.

**PreK Counts Program:** PIC partners with the School District of Philadelphia for the PreK Counts Program that provides child care for income eligible families with 3-5 year old children at no charge from 8am-2pm (family income up to 300% of the federal poverty line.) There are limited slots for the PreK Counts program. Families who need extended care after 2pm each day are charged at the Extended Day rate that is listed on the tuition grid.

**Tuition Assistance:** PIC maintains a modest tuition assistance program to help families who cannot meet the full cost of care and who do not meet the eligibility requirements for the Child Care Works subsidy. Applications are due **May 31** for the next fiscal year and families are notified about financial awards by **June 15**. We understand that individual circumstances may change over any year and assistance requests are accepted throughout the year from families in need.
